# What is NCQA's Electronic Clinical Data Systems (ECDS) Reporting?

- ECDS are networks of data that containing a patient's personal health information (PHI)
- ECDS supports interoperability in reporting of health care quality measures
- Examples of data sources that can be used are:
  - Electronic Health Record (EHR)
  - Health Information Exchange (HIE)
  - Clinical Registry
  - Claims Data
- NCQA Electronic Clinical Data Systems (ECDS) Reporting for some measures such as:
  - Immunizations measures
  - Cancer Screening measures
  - Depression Screening measures



### What is NCQA's Breast Cancer Screening (BCS-E) Measure?

- The percentage of women 50-74 years of age who had a mammogram to screen for breast cancer during the measurement year (January 1 through December 31).
- This measure is <u>only an Electronic Clinical Data Systems (ECDS) Reported</u> measure which means the only way to get credit for it is by appropriate EMR or claims information.
- Health Partners Plans may not perform medical record review for the BCS-E measure.
- Exclusions are:
  - Women with a history of bilateral mastectomies.
  - Women using hospice services any time during the measurement year.



#### **Examples of Best Practices**

- Educate your female members on the importance of screening for breast cancer.
- History of a mammogram can be documented during a telehealth visit.
- Discuss and document your patient's mammogram history at every visit to assure you have the most up-to-date history for your patient.
  - Your patient may have had a mammogram that was reported to their Gyn provider.
  - Include the date of the mammogram in the history and place of service, if known.
  - Include the result of the mammogram.
- Proper coding and documentation of mastectomy history.
- This measure only looks for a breast cancer screening with a mammography; it does not include screenings that were completed with MRI, breast ultrasounds or biopsies.
- Do not code for a mammogram if you give the patient a referral or a prescription; the mammogram must be completed.



### Coding to Improve this HEDIS Measure

The place of service for the mammogram will code for the screening

#### Exclusions

- ICD-10:
  - Bilateral Mastectomy: 0HTV0ZZ,
  - History of Bilateral Mastectomy: Z90.13
  - Absence of Breast (Left and Right)
    - Left Breast (ICD10CM): Z90.12
    - Right Breast (ICD10CM): Z90.11
  - Unilateral Mastectomy (Left and Right)
    - Left (ICD10PCS): 0HTU0ZZ
    - Right (ICD10PCS): 0HTT0ZZ
- CPT:
  - Unilateral Mastectomy with Modifier
    - Unilateral Mastectomy (CPT): 19303, 19304\*, 19305-19307
      - Bilateral Modifier: 50
      - Left Modifier: LT and Right Modifier: RT
