What is NCQA's URI Measure?

- The URI Measure looks at the percentage of episodes for members 3 months of age and older with a diagnosis of upper respiratory infection (URI) that **did not result in an antibiotic dispensing event**.
 - A higher rate for this measure shows the percentage of episodes that the patient was not prescribed an antibiotic this indicates an appropriate treatment.
- The look back period for the URI Measure begins on July 1 of the year before the measurement year (MY) and ends on June 30 of the MY.
 - For example, the URI Measure for HEDIS MY 2023 look back period begins 07/01/2022 and ends 06/30/2023.
- Most upper respiratory infections are viral in nature so antibiotics would not be of value for treatment.
- This measure's intent is to improve antibiotic utilization in order to decrease antibiotic resistant infections.

What is NCQA's URI Measure?

- The age stratifications for these measures are:
 - 3 months 17 years
 - 18 years 64 years
 - 65 years and older
 - Total of all ages

- This measure is only an administrative measure which utilizes pharmacy data.

Examples of Best Practices for the URI Measure

- Do not dispense antibiotics for viral illnesses even if your patient requests them.

- Educate patients, and caregivers on viral illnesses:
 - Difference between viral and bacterial infections.
 - Inappropriate use of antibiotics.
 - Explain other causes for sore throats such as colds or allergies.

Examples of Best Practices for the URI Measure Cont.

- Offer ways to treat symptoms such as:
 - Increased fluids by mouth
 - Over the counter medicines
 - Cool mist vaporizer
 - Throat lozenges
 - Rest
- Explain ways to prevent infection:
 - Wash hands frequently.
 - Clean children's toys.
 - Wipe down frequently touched areas with disinfectant wipes.

Coding tip

• If antibiotics are prescribed for another condition, be sure to include all comorbid diagnosis codes on the claim.
