### **PRODUCT VARIATIONS**

This policy applies to all Jefferson Health Plans (JHP) lines of business unless noted below.

Application of Claim Payment Policy is determined by benefits and contracts. Benefits may vary based on product line, group, or contract. Payment may vary based on individual contract.

### **POLICY STATEMENT**

• Modifier 25 must be used to indicate a significant, separately identifiable E/M service performed on the same day a procedure or other service identified by a CPT code is performed by the same physician or qualified healthcare professional.

• Modifier 25 must be appended to the appropriate E/M service code.

 Both the medically necessary E/M service and the procedure must be appropriately and sufficiently documented by the physician or qualified healthcare professional in the patient's medical record to support the claim for these services, even though the documentation is not required to be submitted with the claim.

### **POLICY GUIDELINES**

Modifier 25 should be used to indicate that on the day of a procedure or service, the patient's' condition required a significant, separately identifiable E/M service above and beyond the usual preoperative and postoperative care associated with the procedure or other service.

Different diagnoses are not required for reporting the E/M service on the same date as the procedure or other service.

### **Jefferson Health Plans**

Claims for E/M services reported with modifier 25 may be subject to other payment rules such as those described in the National Correct Coding Initiative (NCCI) Coding Policy Manual.

Note: The Current Procedural Terminology (CPT®), Healthcare Common Procedure Coding System (HCPCS), and the 10th revision of the International Statistical Classification of Diseases and Related Health Problems (ICD-10) codes that may be listed in this policy are for reference purposes only. Listing of a code in this policy does not imply that the service is covered and is not a guarantee of payment. Other policies and coverage guidelines may apply. When reporting services, providers/facilities should code to the highest level of specificity using the code that was in effect on the date the service was rendered. This list may not be all inclusive.

### **DESCRIPTION OF SERVICES**

The Current Procedural Terminology (CPT) states Modifier 25 may be used to indicate a "Significant, Separately Identifiable Evaluation and Management Service by the Same Physician or Other Qualified Health Care Professional on the Same Day of the Procedure or Other Service."

It may be necessary to indicate that on the day a procedure or service identified by a CPT code was performed, the patient's condition required a significant, separately identifiable Evaluation and Management (E/M) service above and beyond the other service provided or beyond the usual preoperative and postoperative care associated with the procedure that was performed. The significant, separately identifiable E/M service is substantiated by documentation that satisfies the criteria for the respective E/M service to be reported. The E/M service may be prompted by the symptoms or condition for which the procedure and/or service was provided. As such, different diagnoses are not required for reporting of the E/M services on the same date.

# The Centers for Medicare & Medicaid Services (CMS) guidelines for use of Modifier 25 includes the following:

Physicians and qualified nonphysician practitioner (NPP) should use CPT modifier -25 to identify a significant, separately identifiable E/M service provided by the same physician/ qualified NPP to the same patient on the same day as another procedure or other service with a global fee period. CPT modifier 25 should be used when the E/M service is above and beyond the usual pre- and post-operative work of the procedure with a global fee period performed on the same day as the E/M service.

Same physician includes physicians in the same group practice who are in the same specialty. They must bill and be paid as though they were a single physician.

Both the medically necessary E/M service and the procedure must be appropriately and sufficiently documented by the physician or qualified NPP in the patient's medical record to support the claim for these services, even though the documentation is not required to be submitted with the claim. All E/M services provided on the same day as a procedure are part of the procedure and Medicare only makes separate payment if an exception applies.
